## Veterinary Health Requirements for Importation of Cattle in to Sri Lanka

The following requirements should be fulfilled.

	Cestodes Nematodes and Trematodes - The animals to be treated 4-7 days prior to shipment for Cestodes Nematodes and Trematodes (all life cycle stages of Fasciola hepatica) twice with an effective broad spectrum anthelmintic with an interval of 10 - 14 days.	Authority

- 1. The animals should have been kept since birth in exporting country.
- 2. The animals intended to export should be individually identified with a readable Radio Frequency mark enabling them to be traced back to the dam and herd of origin.
- 3. The animals should have been held in registered premises at least for one year and transported to port in clean tracks.
- 4. The animals should have never been fed feed prepared using ruminant protein having either manufactured locally or imported.
- 5. The animals should have not been in contact with any animal showing clinical sign of any infectious or contagious diseases mentioned in paragraph 1, 2 and 3 for a period of minimum three (03) months immediately prior to embarkation.
- 6. The selected animals must be Al born with semen originating from government approved semen collection centres.
- 7. The selected animals should be kept in quarantine station for minimum of thirty (30) days immediately prior to the embarkation at the port of origin.
- 8. Within 3 (three) days prior to the scheduled date of shipment individual animals should be examined and found to be in good health, with no deformities and fit for transport.
- 9. The animals should be transported under conditions laid down by OIE (chapter 7.2 of Terrestrial Animal Health Code 2023) and International Air /Sea Transport Association (IATA/IASA) regulations and comply with CFIA transport regulations.
- 10. The animals to be transported to the point of embarkation without coming into contact with livestock with lesser health status.
- 11. The certificate of the country of origin should be certified by the relevant authority

Health protocol may vary from time to time according to the disease status reported to OIE and the health status of the exporting country
