

Veterinary health requirements for the importation of Frozen Poultry Meat into Sri Lanka
The following requirements should be fulfilled

Status	Disease / Organism	Required test / Certification
Country / Zone free	Notifiable Avian Influenza	Certification by the Government Veterinary Authority
Zone free / Farm free	Newcastle Disease Salmonellosis <u>For Duck meat only:</u> Duck viral enteritis Duck virus hepatitis	Certification by the Government Veterinary Authority
Stock free of importing consignment	E. coli, Staphylococcus aureus Salmonella species	Laboratory certification of Total aerobic plate count within the standard E.coli, (CFU/g) within the standard Staphylococcus aureus (CFU/g) within the standard Salmonella species (Negative)
Anti-mortem inspection	Animals should be healthy and free of diseases	Certification by the Government Veterinary Authority
Postmortem inspection	Animals should be healthy and free of diseases	Certification by the Government Veterinary Authority
Processing procedure		Should be submitted certificate attested by the Government Veterinary Authority
Processing establishment and Slaughter house		Registered and approved by the Government Veterinary Authority
HACCP for processing establishment	Blast freezing low than -35 ⁰ C not less than 4 – 5 hours.	A valid certificate from accrediting national authority
Suitability for Human Consumption		Certification by the Government Veterinary Authority

The certificate of the country of origin should be certified by the relevant authority

Health protocol may vary from time to time according to the disease status reported to OIE and the health status of the exporting country
