Basic Requirements of an Animal Clinic / Animal Clinic & Surgery/ Animal Hospital for the consideration of registration at DAPH

1. Facilities of animal clinic /Animal Clinic & Surgery/ Animal Hospital a. Registration in relevant authorities

Need to fulfill all the registration requirements in relevant authorities that required to proceed the facility legally in that premises.

b. Identification

Clear name board should be displayed in front of the premises with SLVC registration number of the Veterinarian (chief veterinarian when there are more than one veterinarians are occupied) with the license number, emergency contact information.

c. Floor space:

For Animal Clinic: Usable minimum floor area: 150 sq.ft. With door and windows / vents to ensure ventilation.

For Animal Clinic & surgery: Usable minimum floor area: 400 sq.ft. With door and windows / vents to ensure ventilation.

For Animal Hospital Level C: Usable minimum floor area: 1000 sq.ft. With door and windows / vents to ensure ventilation.

For Animal Hospital Level B: Usable minimum floor area: 1000 - 2000 sq.ft. With door and windows / vents to ensure ventilation.

For Animal Hospital Level A: Usable minimum floor area: > 2000 sq.ft. With door and windows / vents to ensure ventilation.

d. Water and Electricity supply :

Uninterrupted electricity supply with the option of backup power system and adequate water supply must be available. This water supply should include portable water and a separate line for surgical areas which is applicable to clinic & surgery, hospital levels.

e. Animal holding facilities:

For Animal Clinic: As a separate isolated room or cage with space at least to hold one large breed adult dog.

For Animal Hospital: At least two separate isolated rooms or cages with space at least to hold one large breed adult dog.

f. Equipment :

- Basic Pair of surgical scissors, Pair of general scissors, six Artery Forceps, two pairs of rat toothed Forceps, two pairs of Allis Forceps, one pair of Needle Holder, Scalpel or two scalpel handle, refrigerator, Thermometer, Stethoscope, examination light source (eg : pen torch), weighing scale (eg: bathroom scale), at least 2 equipment trays, Autoclave or efficient sterilizing device, suture materials and kits (with assorted types and sizes), basic diagnostic tools (eg: Glucometer, Urinalysis strips.)
- Advance for the hospital level Computer and patient record system for digital records

For hospital level B & A - Ultrasound machine, X-ray machine, Oxygen supply system, ECG machine, Crash cart (emergency medication and tools), Emergency resuscitation kit.

g. Facilities for consultation, clients and animal examination:

Veterinarian's table with drawers and chair and additional two chairs in front, and additional chairs for waiting clients,

i. For Animal examinations and treatments

An examination table (Top made of impervious Material), Instrument Troliey, a screen or Curtain to separate examination table, a saline stand, Lockable Cupboard/cabinet, rubber carpet at door step.

Restraining devices (eg: chains, muzzles, squeeze cages etc.) Antiseptics, detergents, disinfectants, brushes, brooms, mops and mop buckets for separate use in the consultation area, examination gloves, hand washing or sanitizing facilities near examination area and client waiting area.

ii. For surgeries (Clinic & surgery, Hospital)

Additional table (Top made of impervious Material) for surgery, an Additional light source to be used as a surgical lamp, a screen or Curtain to separate surgery table or surgical area (including recovery area), Complete set of general surgical instruments, additional cabinet for surgical supplies and instruments, , Surgical drapes, gowns, caps, gloves, masks.

Separate sink in surgical area for scrubbing. Surgical suction apparatus, Anesthetic machine, emergency resuscitation kit (AMBU bag, laryngoscope, endotracheal tubes and emergency drugs.

h. Facilities for hospitalized patients:

For Animal Clinic, Clinic & surgery - Not compulsory

9. Drug Storage Facilities

7.2 Authorized only access - Lockable cupboard / cabinet for controlled drugs (opioids), antibiotics, and restricted-use medications.

7.3 Temperature - Temperature control- Ensure room temp is stable (ideally 15-25°C) unless otherwise specified by label.

7.4 Accepted storage method - Refrigerator for cold-chain drugs - For vaccines, hormones, etc.

7.5 5. Record keeping - Documentation of drug receipts and use , Inward/outward register or software for inventory tracking and audit trails specially for hospitals
