## **GUIDELINES / HEALTH REQUIREMENTS TO FACILITATE THE IMPORTATION OF SHRIMP BROOD STOCK INTO SRI LANKA**

**As a measure to prevent introduction of diseases through importation of Shrimp under section III of the Animals Diseases Act No 59 of 1992 imports are allowed only upon fulfillment of following conditions:**

### **1. Documents Requirements:**

Duly filled application should be addressed to Director/VRA for each consignment of Shrimp:

Following additional documents should be submitted:

- i. Application.
- ii. A copy of a permit issued by the Department of Fisheries to import shrimp species.
- iii. A copy of a recommendation letter from NAQDA.
- iv. Post Quarantine site approval (Report on pre- Import site inspection by Animal Quarantine authority)
- v. Documents to prove the country of transit.
- vi. Official International Veterinary Health Certificate.
- vii. Test report with negative test results for OIE listed specific shrimp diseases.
- viii. A copy of SPF certificate.

The International veterinary Health Certificate should comprise of following additional declaration,

### **Requirement for Importation of Shrimp brood stock into Sri Lanka**

The aquaculture establishment from where this consignment of shrimp is originated is (Specific Pathogen Free establishment) free from following diseases for **two years**.

### **2. Quarantine Requirement**

The consignment will be subjected to Quarantine surveillance at an identified isolated place on its arrival and test the F<sub>0</sub> population for above mentioned diseases in accordance with OIE guidelines to determine the suitability as brood stock. Produced F<sub>1</sub> generation will be subjected to quarantine and test for the diseases. If the above diseases are not detected in the F<sub>1</sub> population, it may be released from quarantine. If the above diseases are detected in the F<sub>1</sub> population, it will be destroyed and disposed in a bio secure manner.

### **3. Other Requirements**

The intended date of arrival of the consignment should be notified to the Animal Quarantine Officer, Katunayake at least four (04) days prior to arrival.

Importer should agree to

- Submit laboratory samples of shrimp and water at the time of Quarantine clearance for further investigation, at the port of entry and during the quarantine surveillance period
- Inform immediately to the Animal Quarantine Officers if you notice any abnormal behavior / shrimp mortality during the quarantine surveillance period.
- Bear all the expenses incurred for testing during this period

**Important:** The conditions of importation may be reviewed, depending on the disease status of exporting countries from time to time and if any outbreak reported, the approvals given will be cancelled
