## **REQUIREMENTS FOR IMPORT OF POULTRY BY –PRODUCTS INTO SRI LANKA**

**Importer should submit the application(FO/VRA/2) with all the supporting documents prescribed in the application.**

Import of poultry by-products into Sri Lanka could be allowed subject to the following conditions:

### **1. Country of origin**

Importation of Poultry by-products will only be allowed from countries officially declared as free from *Notifiable Avian Influenza*. (NAI)

### **2. Processing facility**

The processing facility of the product should be under the supervision of the Government Veterinary Authority of the exporting country and, be registered for export purposes.

### **3. Processing method**

All poultry by –products intended for export to Sri Lanka should be properly washed, cleaned and subjected to one of the following treatments in order to inactivate avian influenza viruses and other infectious agents:

- a. In an airtight container, the product has been sprayed with a 10% formalin ( formaldehyde) solution. The container was left sealed for 8 hours;
- b. The product has been subjected to treatment by fumigation with 10% formalin ( formaldehyde) for 8 hours;
- c. The product has been boiled/steamed at a temperature of 80 ° C or above for a minimum period of 30 minutes.

### **4. Post-contamination**

Precautions should be taken to prevent contamination of the product with pathogenic agents, after processing.

**Important:** The conditions of importation may be reviewed, depending on the disease status of exporting countries from time to time and if any disease outbreak reported, the approvals given will be cancelled
